Tokyo Century Capital (Malaysia) to Promote “Nippon Rent-A-Car” Brand in Malaysia

Tokyo Century Corporation (“Tokyo Century”) is pleased to announce that Nippon Rent-A-Car Service, Inc. (“NRS”), a consolidated subsidiary, and Tokyo Century Capital (Malaysia) Sdn. Bhd. (“TCM”), a consolidated subsidiary based in Malaysia, have agreed on TCM’s use of “Nippon Rent-A-Car” brand in Malaysia.

Following the agreement for the use of “Nippon Rent-A-Car” brand in February 2016 with TISCO Tokyo Leasing Co., Ltd., a consolidated subsidiary based in Thailand, TCM is the second company among our overseas subsidiaries to use the brand.

1. Purpose of brand use and expected results

TCM is a consolidated subsidiary of Tokyo Century, engaged in a broad range of operations centered on equipment leases for Japanese companies as well as local companies in Malaysia. TCM has sought to expand the base of its automobile leasing business, as it has made a full-scale entry into the automobile leasing business in September 2012.

Under the agreement, TCM uses the “Nippon Rent-A-Car” brand in Malaysia to develop its automobile leasing business with the name “Nippon Rent-A-Car Leasing”. Using one of Japan’s best-known brand names, TCM will seek to gain higher recognition for its automobile leasing business and aim to further expand the business.

NRS and TCM will also work together in various ways to promote the use of Nippon Rent-A-Car by tourists and businesspeople from Malaysia, who have been visiting Japan in growing numbers each year.
