TRY Corporation, a Tokyo Century Group Company, Changes Its Company Name and Begins Offering Global-Standard ITAD Services

TRY Corporation ("TRY"), a consolidated subsidiary of Tokyo Century Corporation that provides refurbishing services such as data erasure related to IT assets, has decided to change its capital structure to wholly owned by the Tokyo Century Group, change its name to EPC Japan, K. K. in December 2023, and provide high-quality, world-class ITAD services*.

IT Asset Disposal (ITAD) services are used to rigorously and appropriately dispose of IT assets and include shredding as well as data erasure currently provided by TRY. ITAD services are positioned as an essential aspect of business operations for companies that place high priority on governance and compliance. Demand for these services is growing worldwide, and Japanese companies are also becoming increasingly aware of information security and compliance with environmental laws and regulations.

CSI Leasing, Inc. (CSI), a consolidated subsidiary of Tokyo Century, leases IT equipment in the United States and provides ITAD services at more than 20 locations around the world through its group company, EPC, Inc. (EPC). In order for TRY to utilize EPC's expertise to provide global-standard ITAD services in Japan, CSI will take a 20% stake in TRY, which will be renamed EPC Japan, K.K. This will enable the company to provide high-quality ITAD services for IT assets newly owned by customers, in addition to those with expired leases. We believe this will dramatically increase the Tokyo Century Group's competitiveness.

Going forward, the Tokyo Century Group will focus on providing IT lifecycle management services that combine financial services such as leasing with ITAD services, mainly to customers in Japan who know about information security and are aware of information security issues. We will contribute to increasing the value of the leasing business and to creating an environmentally sound, sustainable economy and society by becoming the best quality provider of ITAD services in the Japanese market.
