Commencement of Electricity Sales under Corporate PPA in the Floating Solar Power Plant Project in Taiwan

Tokyo Century Corporation (Tokyo Century) hereby announces that the ongoing Taiwan-based floating solar power plant project*1 (the Project) started supplying electricity generated through special purpose companies (SPC) to KiWi New Energy Inc. (KiWi) under a corporate power purchase agreement*2 (the PPA) on March 1, 2025.

Since 2018, Tokyo Century has participated in the Project through a joint investment in the SPC with CIEL ET TERRE TAIWAN LIMITED and Fukuoka-based Kyudenko Corporation and Kyuden Mirai Energy Company, Incorporated. The Project has sold all the electricity generated to Taiwan Power Company under Taiwan's feed-in tariff (FIT) system so far, and now its electricity sales arrangement has transitioned to the PPA with KiWi.

Under the PPA, the majority of the electricity generated through the SPC by the Project will be sold to KiWi, ensuring a stable supply of renewable energy. KiWi is dedicated to providing sustainable energy solutions with a focus on its innovative Al-driven green energy trading platform technology. The goal of the PPA is to reduce environmental impact and optimize energy costs. In addition, KiWi plans to supply renewable energy sourced from the SPC to end users Taiwan FamilyMart Co., Ltd. and Decathlon Taiwan Co., Ltd.

The Taiwanese government has been actively introducing renewable energy to achieve the goals of its Pathway to Net-Zero Emissions in 2050, as announced in March 2022. Taiwan has set a long-term goal of expanding solar power generation to 30 GW by 2030 and to 40–80 GW by 2050 to significantly boost the share of renewable energy in total power generation.

Tokyo Century will collaborate with its knowledgeable business partners to continue expanding the supply of renewable energy in Taiwan as well as in Europe and North America, thereby contributing to the further proliferation of clean energy and the realization of a decarbonized society.
